





# PET REGIONS EXPLORED



The US has a data management industry over 20 years old, but faces difficulties in managing legacy technical debts. There are strong incentives for commercialising data but concerns over ownership/ control of valuable datasets. Property protection is an important consideration for digital trust in the US.



EU focuses on security/privacy concerns when it comes to data sharing. Patient privacy and safety are important considerations for digital trust in the EU region. The EU is predominantly focusing on cross-functional collaboration as privacy is becoming an important driver across organisations.



Organisations in APAC are usually more advanced from a privacy skillset perspective, and have been successful in unifying legal and technical priorities for privacy. Digitalisation moves fast in APAC and innovation is much more joined up, with less separation between legal and technology. Digitisation of healthcare is an important consideration for digital trust in APAC.


