#### **NOVEMBER 15 - 9:15AM TRADE SECRET IP IN ANTICIPATION OF THE RISE OF AI**

The use of AI, including machine learning (ML), is turbo-charging the need for active and effective trade secrets management. The situation is highly nuanced, but traditional IP rights, including patents and copyright, were not designed for data or AI techniques and outputs, especially ML. Trade secrets have emerged as the default de facto protection.

- Examine the contribution of trade secret protection towards the protection of data
- Determine how far can trade secret protection contribute towards AI/ML techniques
- Analyse whether trade secret is an enhanced form of IP protection
